Client will be notified before any charges are incurred
3. The studio grants a 6 months cancellation clause. Written notification of any postponement or cancellation of the assignment must be received six months prior to the date of the event. The studio will retain 50% of the retainer as liquidated damages If the studio is available on the new wedding date The retainer will be transferred After the six months cancellation clause date there are no cancellations or postponements. The retainer is forfeited.
4. It is agreed that the client will pay 1/3 of the total fee a week before the event, and the final 1/3 upon delivery of all unedited bulk DVD footage. The studio reserves the right to use Image footage, and/or reproductions for purposes of display, exhibitions, and studio website. Unless otherwise specifically stated herein, negatives remain the property of the studio, however the studio grants the right to the client to make additional reproductions.
